In consideration of the open access publication of the open access, online-only content (the “OA Content”), the Authors of the OA Content agree to the terms and conditions and make the representations and warranties set forth herein.

## **SECTION A: Open Access License**

In consideration of the open access publication of the OA Content, the Authors hereby agree to abide by AJA's open access policy, and hereby grant a license to publish and reproduce the OA Content under the Creative Commons Attribution-Non-Commercial License ("CC BY-NC").
